Budget Message from the LCSD Superintendent of Schools


Preparing Our Students For Tomorrow... Today

I would first like to take this opportunity to thank the Liverpool community for its support of the 2024 Liverpool Central School District Capital Project. Your approval will allow the district to continue to make programmatic and infrastructure improvements necessary to serve the Liverpool community into the future.

New York State approved their budget late again this year. What does this mean for schools? Without a state budget, school districts across the state dealt with many unknowns as we worked on proposed bud-

gets. Inflation is more than 5% in so many important areas and most of our key revenues are less than a 3% increase. This means in an era where our students have more unique needs than ever before, the district has the challenge to do more with less.

Before I get into specifics in regards to the proposed budget, I would like to highlight several accomplishments over the last year.



Based on feedback from the staff, the district created additional K-2 classroom support positions to help our youngest population.

The district is the first district in Onondaga County with multiple campuses to have armed security on every campus.



The Liverpool Central School District's draft budget was presented to the Board on April 17; the proposal demonstrates our collective commitment to our students as the primary focus for all of our work. Specifically outlining the budget changes, we received an increase in state aid (most of that specifically impacting foundation aid) of approximately 1.96% (including other expense-driven aids). Given these adjustments, the Liverpool CSD proposed operating budget has a budget-to-budget increase of approximately 4.23 percent with an estimated local levy increase of approximately 2.10 percent.

The 2024-2025 Budget Public Hearing will be held on Thursday, May 9, at 5:30 p.m. The public will have the opportunity to see and comment upon the proposed spending plan. If you are unable to attend, additional budget information will be posted on the District's Web site as an additional resource to the community.

Community members will have the opportunity to vote on the 2024-2025 budget on Tuesday, May 21, from 6 a.m. to 9 p.m. in the Wetzel Road Gymnasium (4246 Wetzel Road). Voters also will have the opportunity to cast their ballots for Board of Education representation - there are three (3-year) board seats available - as well as a proposition focusing on school buses.




Administrative Component

Proposition #2: Bus & Vehicle Purchase - \$2,481,944

Each year, Liverpool Central School District voters are presented with a proposition to purchase new buses and vehicles for the Transportation and Operations & Maintenance departments.

Why?

The purchases are part of the district's planned vehicle replacement program that keeps its fleet of vehicles in safe, working order and in line with New York State safety standards.

Each day, Liverpool Central School District buses safely transport more than 6,800 students to 38 buildings throughout Central New York, which can result in a great deal of wear and tear over the years.

Typically, the Liverpool Central School District utilizes these school buses and vehicles for approximately 10 years. Like personal vehicles, school buses boast new features every year. By the 10-year mark, older school buses will likely need significant investment in parts and repairs to meet the safety standards of the newer buses.

Proposition #2 Ballot Text:

Shall the Board of Education (the "Board") of the Liverpool Central School District (the "School District") be authorized to purchase student transportation vehicles, at a total combined maximum estimated cost not to exceed \$2,150,544; and other motor vehicles, at a total combined maximum estimated cost not to exceed \$331,400 for a total combined maximum estimated expenditure of \$2,481,944, and shall the Board be authorized to raise the specified sum for these purposes, or so much thereof as may be necessary, by levying a tax upon the taxable property of the School District, to be collected in annual installments in the years and in the amounts as the Board shall determine in accordance with Section 416 of the Education Law; and in anticipation of such tax, to issue up to \$2,481,944 of obligations of the School District?

Candidates for Board of Education

Three terms of office on the Liverpool Central School District Board of Education will expire on June 30, 2024. Successors to these offices will be elected to three-year terms, effective July 1, 2024, through June 30, 2027, at the annual school district election on May 21, 2024. These board seats currently are held by Joseph Morawski, Richard Pento and Katherine Roberts.

My name is **Matt Jones**. Liverpool is my home, where I graduated in 2007 as School-Wide President, fostering a deep sense of pride and connection to our community. My name is **Kimberly Melnik** and I am a lifetime resident of Liverpool and a proud alumni. My children have attended the district, the last will graduate in 2029. I earned degrees from SUNY Oswego and Le Moyne College in elementary and special education. I have taught 3rd, 5th and 6th grade. In 2011, I moved out of the traditional class-



room and began working strictly with Special Education Students aged birth through five years, eventually becoming a preschool director. I joined the team at Southside Academy Charter School, in Syracuse,7 years ago. I have dedicated the last 30 years to ensuring that all students have equal opportunities for quality education regardless of background or circumstances. I went on to work at Bristol Myers Squibb as a Training and Education Specialist and I currently work at National Grid as a Training Developer. I want to do more to advocate for our students and educators through increasing staffing needs where necessary, reduction of shared services and having dedicated resources at each school, increasing the opportunities in the music and fine arts, creating better standards for the CTE programs, and fixing the struggles caused by Education 2020. What are you voting for?

The proposed 2024-2025 Liverpool Public Library Budget

Where will the voting be held?

In the gymnasium of the former Wetzel Road Elementary, 4246 Wetzel Road. This is the same time and place as the Liverpool Central School District vote, but the library is an independent entity and has a separate line on the ballot.

Who is a qualified voter?

A qualified voter is someone who is a citizen of the United States; 18 years of age or older; resident of the Liverpool CSD for at least 30 days before May 21, 2024, either as a renter or property owner; and registered with the Board of Voter Registration or the Onondaga County Board of Elections.

How do you know if you are registered to vote?

You are registered to vote if you are already registered with the Onondaga County Board of Elections to vote in the general election; or you have been previously placed on the register and voted in the last four years. For more information, go to liverpool.kl2.ny.us/budget/index.



BUDGET BREAKDOWN

Patron Services and Programs at 69% represents a major portion of the 2024-2025 budget. This includes expenses related to books, DVDs, CDs, program presenter fees, computer database and software programs and patron service staff.

Administrative represents 14% of the 2024-2025 budget. Administrative costs include legal, consultation and insurance expenses along with office and administration staff.

Operations/Maintenance represents 17% of the 2024-2025 budget. Included in this portion of the budget are building and equipment maintenance and rental fees, service contracts, computer hardware, network software, support staff, maintenance supplies and equipment.

Liverpool CSD Earns School Safety Excellence Award

The Liverpool Central School District is one of at least 160 school districts and Board of Cooperative Educational Services (BO-CES) in New York State to receive the Utica National Insurance Group's "School Safety Excellence Award" for 2024 at the Titanium with Honors level.

This is the 12th year in a row the district has earned this honor, which

is presented annually and recognizes school districts' safety efforts as they work to help keep students, staff and visitors safe.


The district received its award at Utica National's 42nd school safety seminar, one of seven such seminars the company hosts in the state. For 50 years Utica National has kept kids and school staff safe and currently insures more

than 300 school districts in upstate New York alone.

Liverpool CSD officials accepted a certificate to commemorate the district's safety efforts and a \$500 award for use in furthering those efforts from Utica National representatives.

Utica National's School Safety Excellence Award Program has three levels - titanium, platinum, and gold - in which schools can earn a meritorious distinction by meeting specific criteria to enhance overall safety. Through the program, schools with their own transportation, schools with contract transportation, and BOCES are evaluated. Categories covered include bullying prevention programs, playground safety and other areas, and are measured using specific, quantifiable surveys.

"Safety and health concerns continue to be a priority in our school districts," explained Brian Saville, senior vice president in Utica National's Educational Institutions Unit. "Districts that go 'above and beyond' to provide a safe, healthy and focused culture for learning are to be applauded, and we're pleased to count the Liverpool Central School District among them."



Changes to the 2023-2024 Liverpool CSD Calendar

The Liverpool Central School District Board of Education recently revised the District Calendar for the current (2023-2024) school year.

Since the district only utilized two of its emergency/ snow days provided under regulations in New York State Education Law, the board approved an extension to the Memorial Day weekend. **School will now be closed for students and staff on Friday, May 24,** as well as the regularly scheduled Memorial Day Holiday on Monday, May 27.

In addition, the schedule for the last week of school has been revised. Elementary and middle school students no longer need to report to school on Tuesday, June 25, and Wednesday, June 26. Instead, those dates will now be full-day K-8 Professional Development Days for staff.

Please note that in the event the district needs to use an additional emergency/snow day prior to the end of the school year, the district will need to reinstate one of those dates as a full day of school.

DDE Recognized as a Model PLC Community

At Donlin Drive Elementary, the mission is to inspire growth for all – focusing on academics, social-emotional learning and whole-body wellness.

It's because of this mission that DDE recently was recognized as a Model Professional Learning Community at Work.

The teachers and staff at DDE were recognized for their sustained success in raising student achievement by Solution Tree, a leading provider of educational strategies and tools that improve staff and student performance. The school's successful implementation of the Professional Learning Communities at Work (PLC) process was a major contributing factor in the improved achievement of DDE students.

DDE is one of only 13 New York State schools to receive this recognition. Of those 13 schools, only five are elementary schools.

PLCs are schools and districts in which educators recognize the key to improved learning for students is on-going, job-embedded learning for the adults who serve those students. PLCs call on educators to focus on learning, build a collab-

orative culture and create a results orientation.

"As a community, we have worked systematically and collaboratively to ensure all students achieve at a maximum level, "said DDE Principal Heather Silvia. "We are honored to be recognized for the dedication to this commitment of continuous growth and achievement."

Schools are recognized based

on strict criteria, including demonstration of a commitment to PLC concepts, implementation of these concepts for at least three years, and clear evidence of improved student learning over that period. Once measurable results can be seen, the school must explain its practices, structures, and culture and submit its application for consideration by the PLC Review Committee.

LCSD Named One of the Best for Music Education

Who is Eligible to Cast Ballots on May 21, 2024?

Residents living in the Liverpool Central School District can vote during the LCSD School Budget & Board of Education election, as well as the Liverpool Public Library and Board of Trustees election, on May 21, 2024.

Voters must be:

✓ Citizens of the United States; ✓ 18 years of age or

older; ☑ Residents of the school district for at

least a 30-day period

immediately preceding the election; and
☑ Registered with the district Board of Voter Registration or

Voter Registration or the Onondaga County Board of Elections.

Residents who have registered to vote with LCSD, and have maintained that registration by voting in a school district election within the last four calendar years, are properly registered to vote. **Residents**

who are not registered with the district can do so on Tuesday, May 14, at the District Office (195 Blackberry Road in Bayberry) between 9 a.m. and 4 p.m.

Those who currently are registered to vote with the Onondaga County Board of Elections also may vote in school and library elections with no further registration. However, those who are not also entered in the school district register of voters may experience a slight delay at the polls because they will be asked to execute poll records for the district voter file before they will be permitted to vote.

Qualified voters who wish to vote early, will be away from home, or are otherwise unable to vote in person may vote by absentee or early ballot.

Absentee and early ballots can be mailed to residents until May 14.

After May 14, residents must pick them up in Room 1 of the District Office. To obtain an absentee or early ballot application, or for more information, contact the Office of the Deputy Su-

perintendent at 315-622-7148.

The District Clerk must receive absentee or early ballots no later than 5 p.m. on the Liverpool Central School Budget Vote Day (May 21).
