**POLICIES SCHEDULED FOR 5-YEAR RE-REVIEW/RE-ADOPTION**

The following policies were scheduled for Board re-review in 2018-2019. There have been and are no recommended changes to these policies.

**5150 – Contingency Budget** - Based upon NYState Law. Send to BOE, no changes.

**5321 – Mileage** - Send to BOE, no changes.

**5412 – Use of Fleet Fuel Car** - Send to BOE, no changes.

District has fleet cards ie. if fueling station is unusable or on out of town trip. Cards are signed out and limited in use and times.

**7212 – Response to Intervention** - Send to BOE, no changes.

**7350 – Corporal Punishment/Emergency Interventions** - per NYS Rules and Regulations. Cross reference is Policy 7671 Use of Aversive Interventions. No changes. Send to BOE.

**REVISIONS**

**5640 – Smoking/Tobacco Use** – This policy has been revised in order to incorporate recent changes to Public Health Law §1399-n, as well as for consistency with various applicable federal and state laws. This policy now includes vaping. This policy is more adaptive so that it fits the every change environment. Send to BOE.

**6220 – Temporary Teaching Personnel** – This policy has been revised to reflect the June 30, 2018 expiration of the amendments to 8 NYCRR §80-5.4(c), (d) which allowed an uncertified teacher to work up to 90 days as a substitute teacher. Previous to this the District could hire an uncertified

teacher up to 90 days and now it is limited to 40 days for the year. Send to BOE.

**7320 – Alcohol, Tobacco, Drugs, and Other Substances** – The “smoking” section has been removed in order to prevent potential conflict with revised Policy 5640. The otherwise this policy remained the same. Send to BOE.

**7222 – Diploma or Credential Options for Students with Disabilities** – When the NYS Legislature enacted §3204(4-b) of Ed Law, it repealed §4402(9). §3204(4-b) expands graduation participation to any student graduating with a Skills and Achievement Commencement Credential or a CDOS Commencement Credential. The NY State change prompted a change to this policy. Prior to this, only students with a disability who earned a CDOS Commencement Credential were permitted to participate graduation. Cross reference of Policy 7220 Graduation Option/Early Graduation/Accelerated Programs. Send to BOE.

### **NEW POLICY**

**7221 – Participation in Graduation Ceremonies and Activities** – New York Education Law Section 3204 was recently amended to add Section 4-b, which requires districts to permit any student who has been awarded a Skills and Achievement Commencement Credential or a Career Development and Occupational Studies (CDOS, a program the District students have been participating in for years) Commencement Credential, but has not otherwise qualified for a Regents or local diploma, to participate in the graduation ceremony and all related graduation activities of his or her high school graduating class (previously this only applied to students with a disability). This new policy requires districts to provide annual written notice of the policy to all students and their parents/guardians. Send to BOE.
